Subsection (c) Food at Meetings from

Food at meetings:

- (i) Student organizations may be allocated up to a maximum of \$7.00 per person to have food at their club's regular meetings; however, no club/organization may be allocated SGA funds for the purchase of food at regular club meetings more than THREE times in one semester.

Food at meetings:

- (i) Student organizations may be allocated up to a maximum of \$5.00 per person to have food at their club's regular meetings; however, no club/organization may be allocated SGA funds for the purchase of food at regular club meetings more than **twice** in one semester.
